

**THE CHITTAGONG HILL-TRACTS (TARIFF AND
CUSTOMS) REGULATION, 1952**

East Bengal Regulation No. I of 1953

[15th August, 1953]

*A Regulation to apply to the Chittagong Hill-tracts certain
Central Acts relating to tariff and customs.*

WHEREAS it is expedient to apply to the Chittagong Hill-tracts certain Central Acts relating to tariff and customs;

AND WHEREAS by sub-section (2) of section 92 of the Government of India Act, 1935, the ¹ [Government] is empowered to make regulations for the peace and good Government of any area in his Province which is for the time being an excluded, or a partially excluded area;

NOW, THEREFORE, the ²[Government], in exercise of the said powers and all other powers enabling him in this behalf, is pleased to make the following Regulation, namely:-

Short title and commencement **1.** (1) This Regulation may be called the Chittagong Hill-tracts (Tariff and Customs) Regulation, 1952.

(2) It shall come into force at once.

Application of certain Central Acts to the Chittagong Hill-tracts **2.** (1) The enactments specified in Schedule I annexed hereto shall, subject to the amendments mentioned in the fourth column thereof, apply to the Chittagong Hill-tracts.

(2) The enactment specified in Schedule II annexed hereto shall, to the extent mentioned in the fourth column thereof, apply to the Chittagong Hill-tracts.
